FIRST AMENDMENT TO DECLARATION OF COVENANTS, RESTRICTIONS, AND EASEMENTS RIVER BEND UNIT 1 SUBDIVISION

THIS FIRST AMENDMENT TO DECLARATION ("First Amendment") is made this 7th day of March, 1995 by HARRIS BANK NAPERVILLE as Trustee under Trust Agreement dated July 4, 1994 and known as Trust Number 5557 (hereinafter referred to as "Declarant").

WITNESSETH:

WHEREAS, Declarant has heretofore caused that certain Declaration of Covenants, Restrictions, and Easements - River Bend Unit 1 Subdivision to be recorded against the real estate legally described in Exhibit "A" attached hereto and made a part hereof ("Subject Property") on the 2nd day of March, 1995 as Document R95-13594 ("Declaration"); and

WHEREAS, Declarant desires to amend the Declaration by adding Section 8 to Article IV thereof to provide for the subordination of the lien of assessments with respect to certain mortgage interests, all as more fully hereinafter set forth.

NOW, THEREFORE, Declarant hereby declares that the Declaration be and the same hereby is amended as follows:

- Amendment to Article IV. Article IV of the Declaration is hereby amended by adding Section 8 thereto, as follows:
 - "SECTION 8. Subordination of the Lien to Certain Encumbrances. Notwithstanding anything contained herein to the contrary, the lien of the assessments provided for herein shall be subordinate to the lien of any first mortgage or trust deed in the nature of a mortgage now or hereafter placed upon the property subject to Association Assessment; provided, however, that such subordination shall apply only to the assessments and liens which have become due and payable prior to a sale or transfer of such property pursuant to a decree of foreclosure, or any other proceeding in lieu of foreclosure. Such sale or transfer shall not relieve such property from liability for any Association assessments thereafter becoming due, nor from the lien of any such subsequent assessment."
- 2. Continuity of Declaration. The Declaration shall continue and remain in full force and effect in accordance with the terms and provisions therein set forth as originally recorded and as amended by this First Amendment. The provisions of Section 8 of Article IV of the Declaration as established under this First Amendment shall have the same force and effect as if originally set forth and contained in the Declaration. All defined terms set forth in the Declaration shall have the same meaning when utilized

in this First Amendment unless otherwise expressly provided herein.
